Current Families Re-Enrollment: Re-enrollment for students presently attending Spiritus Sanctus Academy and siblings is held during the month of February. A fee of \$225 per family is added to the Tuition and Activity Fee to determine your total due for the next school year. All tuition payment plans must be paid in full by March 1st to re-enroll.

New Student Application Fee: \$35.00 per student

New Families: New applicants will be reviewed after March 1st. Upon acceptance, a **\$500** non-refundable registration fee per new family is due. **\$275** will be applied towards your first month's payment

Family Fundraising Goal: \$1,000.00 per family

This commitment can be met by direct donation or fundraising opportunities in the school

Withdrawal Policy: (Voluntary or involuntary)

Tuition, fees, and any other financial obligations must be current at the time of withdrawal before transcripts will be released.

No Refund Policy:

The School will not refund monies once received. There is no refund for any tuition or fees.
(e.g. The tuition you pay in July will not be refunded if you withdraw before the start of school.)

Financial Aid: The deadline for submitting the financial aid application is **March 3, 2025**.

New families enrolling after this date, who wish to apply for financial aid, should contact the school office for more information.

Late and Returned Item Fee: A late fee of \$30 will be assessed by FACTS for any payment attempt (ACH or Credit Card) that is unsuccessful and also upon three unsuccessful attempts by FACTS of any single payment an additional \$30 SSA late payment fee will be assessed.

For any payment made by check, if returned for any reason, SSA will charge a \$25 processing fee.
